2023-2024 SCHEDULE OF TUITION AND FEES

TUITION

Grades K through 12: \$6,050

Pre-Kindergarten: \$5,104

Pre-Kindergarten (Morning Only): \$3,974

Multi-Child Discounts

- The second child from the same family and residence receives a 5% tuition discount.
- The third child from the same family and residence receives a 25% tuition discount.
- Four+ children from the same family and residence receive a 30% tuition discount.

Payment Plans

- **Plan A:** All tuition and fees paid in full by June 1, 2023. A 3% discount is applied to **tuition only**. No early payment discount is available for enrollments after the beginning of the school year.
- **Plan B:** The full tuition amount is divided into 2 semester payments. One-half of the full year's tuition is due by June 10, 2023. The second half of the tuition is due by January 10, 2024.
- **Plan C:** The full tuition amount is divided into 12 monthly installments with the first payment due by June 10, 2023 and the last payment due by May 10, 2024.

FEES (There are no discounts on fees. Fees detailed below apply to all students/families)

Per STUDENT

- \$100 (or \$200) Registration Fee: Required each year to secure a place in the class and due with the signed enrollment contract. (**see NOTES below)
- \$150 Book Fee: Annual fee to help offset the costs to the school of textbooks and other educational materials.
- \$100 Technology Fee: Funds are used exclusively for school technology.
- \$50 Activity Fee: This covers student accident insurance and provides free admission to all regular season home athletic events for DEA students.

Per FAMILY

- \$100 Building Fund Assessment: One annual fee required of each family, regardless of the number of children enrolled. The funds are used exclusively for facility needs.

NOTES

- **The \$100 registration fee is due **with** the enrollment contract. (\$100 per student registration fee for returning families is available until February 24, 2023. Beginning February 25, 2023, the registration fee for returning families increases to \$200 per student).
- The building fund assessment, book fee, activity fee, and technology fee are all due **prior to the first day** of school in August, 2023. All fees must be paid to begin the school year.
- A 2% per month late fee will be assessed for any carry-over balances including: tuition, fees, cafeteria, incidentals, etc. which are not paid by the 10th of each month.
- Tuition is pro-rated for enrollment after the beginning of school. Some payment plans may not be available in cases of late enrollment.
- After 3 returned checks, families must pay with cashiers check, cash, or credit card only. All returned checks result in a \$35 returned check fee. DEA will not accept post dated checks for any transaction.
